What is Citational Justice?

- Giving credit where credit is due and respecting the historical record of published literature.
- Assuming individual personal and professional ownership of the duty and responsibility as a teacher or student to search, cite, reference, and discuss the original work of the original authors in open scientific debate of the artifacts, data, metadata, documents, and content published in online and offline media, libraries and repositories.
- Refraining from plagiarism; refraining from the silencing, gaslighting, and ghosting of the victims of plagiarism; refusing to participate in elaborate fiefdoms, collusion rings, citation cartels, and other forms of organized fraud in academia and scholarly research publishing.
- Collaborating with other scholars to correct mistakes that appear in the published literature so that science remains a verifiable, reproducible, accountable and self-correcting endeavor that benefits all of us who believe in defending, protecting, and preserving life on planet Earth.

Lying, Liars, and Lies

- Study of lying focuses on the behavior: analysis of the recurring patterns of actions and interactions of liars with other persons and groups including liars, non-liars, and truth-tellers.
- Study of liars focuses on the persons: analysis of the individuals and/or groups of individuals who propagate and perpetuate the lies.
- Study of lies focuses on the content: analysis of the wrongful or untruthful information.
- What if we view the collective phenomena of lies, liars, and lying in a societal culture and community as an abnormal disorder that harms global public health?
- What if we named that abnormal disorder as a defined and described syndrome for further study and analysis?

Global Pandemic of Darvomania

- Do liars spread lies and lying in a manner analogous to an infectious disease as a public health hazard?
- Do adjectives such as *narcissistic*, *sociopathic*, *or psychopathic* to modify the noun *liar* adequately convey the dangers of the malevolent propaganda and lies in today's information wars?
- What about combining the acronym DARVO for the phrase "Deny, Attack, Reverse Victim and Offender" (from the published work of Dr. Jennifer Freyd) with the word mania well-known to lay persons, citizen scientists, and professional clinicians and medical doctors?
- How many political leaders, and how many of their followers, in how many countries around the world have been infected by the global pandemic of darvomania?
- What will be the vaccine and the cure that stops the spread of this global public health hazard of darvomania?

Who are the Guardians of Truth and Integrity?

- BHAVI will host an annual Guardians workshop every October.
- We will accept nominations each year for Guardians of Truth and Integrity but will not necessarily award the honor each year.
- We will only recognize a nominee as a Guardian of Truth and Integrity
 if we believe the scholar has served as a lifetime defender of truth and
 integrity, and has risen to the highest level of commitment to action
 and intervention speaking truth to power.
